PATROL REPORTS: COMPLAINANT STATES THAT A GROUP NAMED "KEPRI" HAS PAINTED SOME SYMBOLS IN REGARDS TO THEIR ORGANIZATION IN THE AREA OF MT. NIMHAM AND ON THE FIRE TOWER.

PATROL OBSERVED PICTURES OF SAME TAKEN BY COMPLAINANT. ORGANIZATION "KEPRI" IS ALLEGEDLY AN ORGANIZATION RESEARCHING MANY OF THE STONE CAVES AND CHAMBERS IN REGARDS TO PARANORMAL ACTIVITY.
