- 1. Plaintiffs are residents of the County of Westchester.
- 2. Upon information and belief, the defendant is a resident of the County of Westchester.
- 3. At all times herein mentioned, upon information and belief, the defendant was the owner of premises located at 37 West Main Street, Mt. Kisco, New York.
- 4. At all times herein mentioned the defendant upon information and belief, controlled the aforesaid portions thereof.
- 5. Upon information and belief, the defendant controlled the common areas of said premises.
- 6. At all times herein mentioned, the defendant maintained the aforesaid premises including the maintenance thereof.
 - 7. On January 15, 1991 at or about 9:00 A.M and several days

preceding that date, the defendant's agents, servants or employees failed to remove accumulated snow and ice from the surface area of the parking lot area.

- 8. On January 15, 1991 at or about the aforesaid time and place, the plaintiff KATHRYN BAUM, slipped and feel at the premises commonly known as the parking lot area located at 37 West Main St., Mt. Kisco, New York.
- 9. By reason of the aforesaid fall, the plaintiff KATHRYN BAUM, became injured.
- 10. Due to the aforesaid fall the plaintiff KATHRYN BAUM became seriously and permanently injured.

14. At all times herein mentioned the plaintiff GEORGE BAUM was the husband of the plaintiff KATHRYN BAUM.

15. By reason of the foregoing, the plaintiff GEORGE BAUM suffered the loss of services of his wife all to his damage and detriment in the amount of \$250,00.00.

WHEREFORE, plaintiffs demand judgment on the first cause of action in the amount of \$1,000,000.00 and on the second cause of action in the amount of \$250,000.00 together with the costs and disbursements of this action.
